2021 CSA CONVENTION APPLICATION

After a year's hiatus due to COVID, the CSA will once again hold its annual conference. As in the past, the Long Island Region is once again offering to subsidize LI Region Members to attend the 2021 CSA Convention at the Hilton, October 30, 2021. Although the CSA has placed a \$100 retiree registration fee for the conference, the LI Region will subsidize that by 50%. Yes, that's right. If you want to attend the conference, all you pay is **\$50.00!!!!** And if you want to bring your spouse, the LI Region will subsidize your spouse's conference fee by 50% as well, provided your spouse is NOT an active CSA member. Here's all you need to do:

- 1) Complete the form below and return it so that it is **RECEIVED** by **October 15, 2021**, along with your check payable to **CSA-LI Region** in the proper amount, at the above address.
- 2) Please note that the application and your check must be **RECEIVED**, not postmarked by October 15, 2021. Checks received AFTER October 15, 2021 will not be eligible for the subsidy and will be returned. No Exceptions!!!!
- 3) If you complete the application on the CSA web site and make a direct payment of the full amount (\$100) directly to CSA, we cannot subsequently send you a refund check for \$50.00. Only members who follow these instructions will be eligible for the subsidized price.
- 4) We will send a list of those LI Region members who are attending the conference to CSA. You will not receive any confirmation from CSA or the LI Region. Simply show up. CSA will have a list of those people who the LI Region has registered, and materials will be available for you at the Retiree check-in desk at the conference.
- 5) If you are attending the morning session only (not staying for lunch), you **MUST** complete the Retiree Chapter Discounted Conference Registration and send that directly to CSA. Do Not complete this form. This form is **ONLY** for LI Region Members who are staying for lunch.
- 6) Only members who are current in their dues will be eligible for the subsidy. If you have not as yet paid your dues and wish to pay your dues at the time you apply for the subsidy, you **MUST** complete **both** the dues renewal form as well as this application and return **both, paying with separate checks. Do not pay for both the luncheon and your dues with one check.** A dues renewal form is included if needed. You may return both to the above address in the same envelope. If you wish to only pay your dues, simply complete only the dues renewal form and return it with your check.
